Mr. Stewart is a member of the Board of Directors of Baker Hughes, Delta SubSea, The Alley Theatre of Houston, and a Trustee of the Menil Collection and Chair of the Finance Committee of the Menil Collection.

Evelyn Angelle is an accomplished finance and accounting executive with more than 25 years of experience in various senior audit and financial management roles. Most recently, Ms. Angelle spent 12 years at Halliburton working in various senior roles, including Senior Vice President of Global Supply Chain, Chief Accounting Officer and Vice President of Investor Relations. Before Halliburton, Ms. Angelle spent 15 years in Ernst & Young LLP’s audit practice. She is a Certified Public Accountant and Certified Management Accountant.
